

#### **PORT OF NAPIER**



Port Napier of unsuccessfully sought an injunction last week to force our crane drivers to train ISO staff. The Employment Court accepted the seriousness of the health and safety concerns our members raised. That issue is going to mediation, and if not resolved by agreement, to a dispute in the Authority. Since last Saturday Port of

Napier has had a MUNZ picket line across all entrances since Saturday early Morning. Our Port and Rail members have refused to cross the picket line since this time. On Tuesday the Port obtained an injunction forcing our members across the picket. The health and safety issues involving ISO staff remains a very important issue, and we will keep you posted. We are all proud to be RMTU today!

#### TANGIWAI 24<sup>TH</sup> DECEMBER 2007.

The Palmerston North Rail branch of the RMTU has taken responsibility for a vast number of years of placing a wreath into the river off the Overnight Northerner Passenger service to remember the lost souls on the fateful passenger train crash at Tangiwai on

Christmas Eve in 1953. RMTU particularly remembers the Enginedriver Charlie Parker and the Fireman Lance Redman.

With the demise of the Northerner train in recent years the branch has had to adopt alternative strategies to ensure that we continue to remember the loco crew and the others who died that night in the cold harsh waters at Tangiwai. This year the plan is to have two floral tributes. A larger tribute for the memorial site to be delivered, possibly by the LE on car-244, and a smaller for LE on 200, both to be delivered on the day. This worked well last year, with a small group at the site at the time who happened to be passing by. A BIG thank you to the Palmy Branch!

#### **UNION MEMBERSHIP UP AGAIN**

"The numbers of workers joining together

in unions is increasing steadily with further growth in 2006, particularly in the private sector," CTU secretary Carol Beaumont said today, in response to Victoria University's annual survey of union membership.

"Union membership has increased every year for the last seven years, with a lift of 5,000 members in 2006 meaning that there are 80,000 more workers in unions since the end of 1999."

"Critically, we are seeing growth in the private sector. This area demands our attention, and we have plans to keep on growing."

"The dedicated union activity in retail and hospitality has seen the biggest rise in this sector last year for some time. While there is still a lot of work to increase the numbers of workers coming together collectively in these sectors to challenge low pay, the signs are positive."

"2006 was a significant year for union activity; including a huge union campaign against an attack on workers' rights

through the 90 Days No Rights Bill, and union leadership and solidarity at all levels played a crucial role in beating the brutal lockout of 500 supermarket supply chain workers."

"The union movement is positive, growing and determined. We have become a more active and visible union movement over recent years. Our union agenda for workers is broad, and we will continue to campaign for decent conditions and a fair share at work." Carol Beaumont said.

#### **UNION FEE INCREASE**

Union fees were increased by unanimous vote of the delegates to the National Conference to the following:

- \$7.30 per week for full-time members
- \$14.59 per fortnight for full-time members
  - \$31.66 per month for full-time members
  - \$1.08 per day for daily casuals
  - \$3.65 per week or \$7.30 per fortnight for parttime employees working less than 20 hours per week
  - \$3.65 per week or \$7.30 per fortnight for trainees/apprentices earning remuneration below a determined

amount.

All employers (excluding those Port employers where our members pay above the new union fee) have been sent letters on 20 November requesting that fees be increased immediately from the next pay period.

The Chairman and Trustees of The New Zealand Locomotive Engineers' Sickness, Accident & Death Benefit Fund, 'the Fund' are pleased to announce that the

Benefits and contributions for Pre 2004 Members have also increased by 26.9% and receive benefits as detailed in the First Schedule of the Trust Deed.

Branch Secretaries hold update of membership forms that you can post or fax in or alternatively for immediate action members are reminded to utilise the update of membership details link on our website www.rmtunion.org.nz.

For example - All rail industry employment agreements expire in 2008 and so there will be ratification votes conducted by mail. If we have the incorrect address, employer info you will not get a vote as you will never receive a voting paper.

#### ONTRACK MECA

Our ONTRACK members will be wondering where their MECA information and ballot papers are? Well, there is a complication. Infrastructure CA expires 31 March 08 and the Network on 30 June 2008. The Employment Relations Act has a very prescriptive timeline for when ballots are to be conducted and so the ballot papers cannot leave National Office until the

beginning of January 08. Therefore the ballot papers will be posted on 7 January. The ballot will close at 0900hrs 28 January 2008 and be counted on the 29th.
